Business Names

What You Need to Know

Introduction

Registering a business name is a formal process that allows individuals or partnerships to legally operate under a distinct name, differentiating their business from others in the marketplace.

Key Provisions

Having a business name is ideal for small ventures like home-based businesses, small family businesses, farms, cooperatives, or gig workers. It allows trading under a unique identity but does not provide limited liability protection. The process involves an online reservation and registration application through the Uganda Registration Services Bureau (URSB).

Important Note

If you are operating as a sole trader, even with a registered business name, the business is not a separate legal entity from its owner. This means the owner is personally responsible for all debts and losses of the business.

Qodobbada Muhiimkaah

Lahaanshaha magac ganacsi waxay ku habboon tahay ganacsiyada yaryar sida ganacsiyada guriga ku salaysan, ganacsiyada qoyska yar yar, beeraha, iskaashatooyinka, ama shaqaalaha gig. Waxay u ogolaataa ku-ganacsiga aqoonsi gaar ah laakiin ma bixiso ilaalin xaddidan. Nidaamku wuxuu ku lug leeyahay boos sii qabsi online ah iyo arjiga diiwaangelinta iyada oo loo marayo Xafiiska Adeegyada Diiwaangelinta Uganda (URSB).

Xusuusin Muhiimah

Haddii aad u shaqaynayso sidii ganacsade keligiis ah, xataa adigoo wata magac ganacsi oo diiwaan gashan, ganacsigu maaha wax sharci ah oo ka gooni ah mulkiilaha. Tani waxay ka dhigan tahay in mulkiiluhu uu shakhsi ahaan mas'uul ka yahay dhammaan deymaha iyo khasaaraha ganacsiga.

Application Requirements

To reserve and register a business name, you will need a valid email address and a phone number for creating a URSB account and the following:

National applicants:

- National ID
- An official business email address

Non-National applicants:

- Passport or Refugee ID
- An official business email address



Steps to Reserve and Register a Business Name

Follow these steps to reserve a business name:

1. Access the Online Business Registration System (OBRS) at <https://obrs.ursb.go.ug>
2. Check if the business name you want is available; if not, try a different name.
3. Log into your URSB account, or create an account. Submit the reservation request and pay the required fee.
4. An email confirmation will be sent and notify you of approval, queries, and issue of the Certificate of Registration of a Business Name.

Note: The name is reserved for one month to complete the registration step.

Follow these steps to register a business name

1. Log into your URSB account at <https://obrs.ursb.go.ug/>
2. Navigate to the "Register Business Name" option from the menu and complete the registration forms, including an official business email address.
3. Download, print, and sign the form; upload the signed copy with IDs, pay the required fee and submit the application.
4. An email confirmation will be sent with a tracking number.
5. The registry will review the application and notify you by email of approval or queries within a specified period. If approved, you will receive an activation link to set a password and access your business account.

Costs: The required fees include 35,000 UGX for name reservation and 55,000 UGX for name registration.

3. Gal akoonkaaga URL-ka, ama samee akoon. Soo gudbi codsiga boos celinta oo bixi kharashka loo baahan yahay.
4. Xaqiijinta iimaylka ayaa lagu soo diri doonaa oo ku ogeysiin doona oggolaanshaha, weydiimaha, iyo soo saarista Shahaadada Diiwaangelinta Magaca Ganacsiga.

1. Geli akoonkaaga URL-ka <https://obrs.ursb.go.ug/>
2. U gudub "Magaca Ganacsiga ee Diiwaangelinta" ikhtiyaarka menu oo buuxi foomamka diiwaangelinta, oo uu ku jiro ciwaanka rasmiga ah ee ganacsiga.
3. Soo deji, daabac, oo saxeex foomka; soo rar nuqulka saxeexan ee aqoonsiyada leh, bixi kharashka loo baahan yahay oo soo gudbi codsiga.
4. Xaqiijinta iimaylka waxaa lagu soo diri doonaa lambarka raadraaca.
5. Diiwaangelintu waxay dib u eegi doontaa codsiga waxayna kugu ogeysiin doontaa iimaylka oggolaanshaha ama su'aalaha muddo cayiman gudaheed. Haddii la oggolaado, waxaad heli doontaa xiriiriye firfircooni si aad u dejiso furaha sirta ah oo aad gasho akoonkaaga ganacsiga.
