Introduction

The Landlord and Tenant Act 2022 outlines the rights and responsibilities of landlords and tenants in Uganda, ensuring fair and lawful rental practices.

Key Provisions

The Act protects landowners and tenants, including:

- ✓ **Security of Tenure:** Protects tenants from unfair eviction and requires landlords to give proper notice before ending a tenancy.
- ✓ **Rent Regulation:** Stops unfair rent hikes and sets rules for rent reviews and resolving disputes.
- ✓ **Property Standards and Repairs:** Requires landlords to keep properties liveable with basic amenities and allows tenants to request timely repairs.

Importance of Written Tenancy Agreements

Although verbal agreements hold legal weight in Uganda, opting for a written agreement provides increased protection. Written contracts safeguard the rights of both landlords and tenants by clearly defining their responsibilities and expectations. They offer documented proof and a shared understanding of the tenancy terms, including rent, duration, and obligations.

Enyanjula

Byewetaaga okumanya

Etteeka lino likuma bannannyini ttaka n'abapangisa omuli:

- ✓ Obukumi bw'Obupangisa: Bukuuma abapangisa obutagobwa mu ngeri etali ya bwenkanya era kyetaagisa bannannyini mayumba okuwa ekiwandiiko ekituufu nga tebanagoba mu mayumba.
- ✓ Okulungamya ebisale by'obupangisa: Liyimiriza okulinniyisa ebisale by'obupangisa mu ngeri etali ya bwenkanya n'okugonjoola enkaayana.
- ✓ Omutindo gw'ebizimbe n'okuddaabiriza: Eteeka lyetagisa bannannyini mayumba okukuma ebizimbe mu mbeera ennunji n'ebyetagisa byonna era lisobozesa abapangisa okusaba okuddaabiriziba kw'ebizimbe mu budde.

Obukulu bw'endagaano z'okupangisa eziri mu buwandiike

Wadde nga endagaano z'omumwa zirina obuzito mu mateeka ga Uganda, okusalawo okukozaesa endagaano y'omu buwandiike kyongera obukumi. Endagaano z'omubuwandiike zikuuma eddembe lya bannannyini mayumba n'abapangisa nga zirambika bulungi obuvunaanyizibwa bwabwe n'ebyo bye balina okusuubira. Ziwa obukakkafu obuwandiike n'okutegeera awamu ku mateeka g'obupangisa, omuli ssente z'obupangisa, ebbanga lye bamala, n'obuvunaanyizibwa bwa buli omu.

Rights and Responsibilities

The Act also outlines the rights and responsibilities of both parties .

The parties in a tenancy agreement may act through agents, but this must be documented in writing.

For Landlords

- Fair Treatment:** Treat tenants respectfully and avoid discrimination based on race, gender, religion, or disability.
- Maintenance:** Ensure the rental property is fit for habitation and meets health and safety standards. You are responsible for repairs to the exterior, common areas and essential amenities, provided that the need for these repairs is not due to tenant negligence.
- Privacy:** Respect tenants' privacy rights. You can inspect the property during the day, but you must provide 24 hours' notice to the tenant, except in emergencies.
- Taxes:** The payment of taxes imposed by law on the property is your responsibility.
- Quiet Enjoyment:** Ensure tenants have quiet enjoyment of the property during their tenancy.
- Rent:** Issue a receipt for rent paid. You must provide 60 days' notice for any rent increase, which cannot exceed 10% annually.
- Eviction:** You cannot evict a tenant except when you act in accordance with the law.

For Tenants

- Payment of Rent:** Pay rent on time and in full to avoid eviction proceedings.
- Property Care:** Maintain the property, promptly report damages or maintenance issues to the landlord and repair urgent issues. The landlord must reimburse you for urgent repairs upon receiving notice.
- End of Tenancy:** Provide proper notice if terminating the agreement and understand notice periods and deposit refunds.
- Utility Bills:** You are responsible for paying for utilities such as water, electricity etc.
- Conduct and Use:** Do not use the premises for illegal purposes, cause a nuisance to neighbours or others, or sublet the property or part of it without the written consent of the landlord.
- Alterations:** Do not make alterations or fixtures without notifying the landlord.

For Both

- Termination:** The tenancy can end by mutual agreement, at the end of the lease term, with advance notice given within a reasonable period, or as required by law.

Eeteeka era lirambika eddembe n'obuvunanyizibwa bw'enjuyi zombi

Enjuyi eziri mu ndagaano y'obupangisa ziyanza okukola nga ziyyita mu ba agenti naye kino kirina okulambikibwa mu buwandiike.

Eri ba landiroodi

- Okuyisibwa mu ngeri y'obwenkanya:** Abangisa bawe ekitiibwa era wewale okubasosola okusinziira ku mawanga, ekikula ky'omuntu, eddiini oba obulemu
- Okuddaabiriza:** Kkakasa nti ekifo ky'obupangisa kiri mu mbeera nnunji era nga kituukana n'omutindo gw'ebyobulamu n'obukumi.
- Okubeera n'obulamu obw'ekyama:** Toyinjira ddembe lya mupangisa. Osobola okwekebejja ekifo kino emisana, naye olina okuwa omupangisa okutegezeebwa okumala essaawa 24, okuggyako mu mbeera ez'ebigwa bitalaze.
- Emisolo:** Okusasula emisolo egayeekebwalo mu mateeka ku kizimbe kyo buvunanyizibwa bwo.
- Obutayingirira mupangisa:** Kkakasa nti abapangisa bo tobayingirira ku ttaka oba kizimbe ebbanga lye bamala nga bapangisa bo.
- Ssente z'obupangisa:** Wa lisiti ya sente ezisasuddwa. Olina okuwa okutegeeza nga kwa nnaku 60 nga tonalinnysa bisale bya bupangisa era tebirina kussukka 10% buli mwaka.
 - Okugobwa ku nnyumba:** Tosobola kugoba mupangisa okugyako nga okikola ogoberer amateeka.

Eriabapangisa

- Okusasula sente z'obupangisa:** Sasula sente mu budde era mu bujuvu okwewala okusengulwa.
- Okulabirira w'opangisa:** Labirira ekizimbe, loopa ebyonoonese eri landiroodi mu bwangu era ddaabiriza ebyo ebyetaaga okuddaabirizibwa mu bwangu. Landiroodi eteekeddwa okuddizza sente zo nga omaze okuddaabiriza oluvannyuma lw'okumutegeeza.
- Enkomerero y'obupangisa:** Waayo okutegeeza okutuufu singa oba ova mu nnyumba era otegeere ebiseera by'okulangirira n'okuddizibwa ssente.
- Ebisale by'ebikozesebwa:** Ovunanyizibwa okusasula ebikozesebwa nga amazzi, amasanyalaze n'ebirala.
- Empisa n'enkozesesa:** Tokozesa ekifo mu ngeri emenya amateeka, okutawaanya baliraanwa oba abalala, oba okupangisa ekifo ekyo ekitundu kyakyo nga tolina lukusa lwa landiroodi mu buwandiike.
